

Compliant Heavy Lift Tow Truck Operators

Heavy Lift Tow Truck (HLTT) operators not listed below must apply for a Heavy Lift Tow Truck Single Movement Permit.

The following HLTT operators meet the necessary requirements, allowing them to tow a heavy vehicle under their current Heavy Lift Tow Truck Statutory Mass Period Permit, provided the HLTT does not exceed statutory mass limits.
