In order to obtain the *Heavy Lift Tow Truck Period Permit*, all the eligibility requirements must be met and evidence of such provided to Main Roads Heavy Vehicle Services. The *Heavy Tow Truck Period Permit Supporting Evidence & Eligibility Checklist* is available on our website and must be submitted with your permit application, along with the relevant supporting evidence. You must also be an Accredited Operator with Main Roads WA (WAHVA).

Please ensure that all vehicles listed on this permit application have been registered with Main Roads. Authorised Officers will have access to the information you provide for compliance and enforcement purposes. Your personal details will not be disclosed to any other third party without your consent unless required to do so by law or for purposes mentioned in the Information Privacy Act 2009.
