



NOTES:

1. Minimum 3 Pilot vehicles required to facilitate contra flow movement.
2. Road Network Operations Centre shall be contacted (138 111) prior to commencing Oversize movement and at the conclusion of the contra flow movement.
3. Direct UHF radio communication is to be maintained between Pilot vehicles, Oversize vehicle(s) and Traffic Escort vehicle at all times.
4. Bollards to be removed prior to the approach of the Oversize vehicle(s).
5. Oversize vehicle(s) shall not begin the contra flow maneuver until notified that all traffic is stopped and the route is clear of traffic.
6. Pilot vehicle 1 & 2 shall move to the locations shown on Mercury Rise and stop all traffic to allow the Oversize vehicle(s) to execute the maneuver to enter the Over-Height Vehicle Bypass:
 - Pilot vehicle 1 shall stop eastbound traffic prior to intersection of Mercury Rise and Great Northern Hwy;
 - Pilot vehicle 2 shall stop westbound traffic prior to intersection of Mercury Rise and Great Northern Hwy;
 - Pilot vehicle 3 shall shadow the Oversize vehicle(s) to control trailing traffic during the Oversize vehicle movement onto the Over-Height Vehicle Bypass.
7. Pilot vehicle 4 and 5 required after the construction of Canaveral Way and Verlot Drive to stop westbound traffic on those roads.
8. Once the load has entered the Over-Height Vehicle Bypass, Pilot vehicles 2 and 3 shall move to the locations shown on Great Northern Highway and stop all traffic to allow the Oversize vehicle(s) to execute the maneuver to exit the Over-Height Vehicle Bypass:
 - Pilot vehicle 1 shall stop southbound traffic on Great Northern Hwy;
 - Pilot vehicle 2 shall stop northbound traffic on Great Northern Hwy;
 - Pilot vehicle 3 shall shadow the Oversize vehicle(s).
9. Once the Oversize vehicle(s) are clear of the Over-Height Vehicle Bypass onto Great Northern Hwy, the Pilot vehicles can release traffic and continue with duties as required.
10. Traffic management shall reinstate bollards at both ends of the Over-Height Vehicle Bypass when Oversize vehicle(s) are clear.
