1 INTRODUCTION

Main Roads Western Australia (Main Roads) proposed to construct the Roe Highway Extension as part of the Perth Freight Link project. This involved the construction of approximately 5 km of highway, extending Roe Highway from its current terminus at the Kwinana Freeway in Jandakot to Stock Road in Coolbellup. The design and construction of Roe Highway Extension was awarded to the Building Roe 8 Alliance (BR8), formed between Main Roads, CPB Contractors, Georgiou Group, WA Limestone, GHD, AECOM and BG&E.

On 12 March 2017, the action was paused following the WA State election, halting any further clearing or other works other than those required to maintain a secured and safe site. On 3 April 2017, works were officially suspended. Since the suspension of works, the Alliance has been renamed the Metropolitan Road Improvement Alliance (MRIA).

Whilst implementation of the full action has ceased, the State Government announced on 8 May 2017 that the eastern end of the action, known as the Murdoch Drive Connection (MDC) would be implemented immediately by MRIA. This portion of the action surrounds the Kwinana Freeway and Roe Highway interchange, and continuing towards Bibra Drive, will provide a new access into the Murdoch Activity Centre (MAC).

Construction and operation of the MDC is fully contained in the section of the proposal development envelope (PDE).

The action is located approximately 14 km south of Perth within the Swan Coastal Plain Bioregion. The action is largely contained within the City of Cockburn, however, parts of the design extend northward to the City of Melville along Murdoch Drive and the Kwinana Freeway.

1.1 Approval under the *Environment Protection and Biodiversity Conservation Act* 1999

Roe Highway Extension was assessed by the Commonwealth Department of the Environment and Energy (the Department) under the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act) after it was referred by Main Roads on 22 June 2009, as the action impacts listed threatened species and communities, and listed migratory species. Approval under the EPBC Act was issued on 21 October 2015 with conditions (EPBC 2009/5031).

MDC will proceed in accordance with the conditions in EPBC 2009/5031 and the WA Ministerial Statement 1008 (MS 1008).

1.2 Purpose of this Report

This report has been produced to meet the requirements of Condition 12 of the approval under the EPBC Act. It namely addresses compliance with approval conditions and implementation of any management plans and strategies as specified within the approval.

This is the first annual report prepared by MRIA on behalf of Main Roads to fulfil this condition, and covers 5 December 2016 to 4 December 2017.

2 PROGRESS TO DATE

The action commenced on 5 December 2016, which included the commencement of native vegetation clearing on 19th of that same month.

On 12 March 2017, site establishment works were paused, with the works officially suspended on 3 April 2017. At this point 39.96 ha of native vegetation had been cleared, with the majority of cleared vegetation mulched.

The State Government announced on 8 May 2017 that construction of MDC would commence immediately by MRIA.

Since the commencement of MDC works, an additional 0.54 ha of native vegetation has been cleared, with temporary earthworks commencing on 28 November 2017 and permanent earthworks on 5 January 2018. Other site establishment works such as asbestos removal, weed control, fencing and fauna fencing have since been completed, and will continue as required.

All site remediation activities west of Bibra Drive have been completed and handed back to the community, including the following:

- Design and construction of fencing
- Removal of mulch piles
- Removal of previously illegally dumped asbestos
- General civil works to assist with rehabilitation works
- Weed control.






Figure 1 Clearing area to date



Cleared under Roe 8



4 NEW ENVIRONMENTAL RISKS

No new environmental risks were identified during the reporting period.

5 CONCLUSION

The first year of works resulted in the suspension of the Roe Highway Extension Project, completion of site remediation to the west of Bibra Drive and the commencement of the MDC construction works. The works remaining for MDC include its continued construction, with some investigation and design works remaining to realign and extend Murdoch Drive as a four lane dual carriageway to Kwinana Freeway at the Roe Highway interchange.

The action was partially compliant with Condition 5 and Condition 6 and fully compliant with all remaining applicable conditions under the EPBC Act approval.

The partial compliance of Condition 5 is a result of a minor non-compliance identified in relation to MS 1008 Condition 7-10. Namely piles of topsoil and mulch were not appropriately signposted in accordance with the requirements of the condition. Once the error was identified, the non-compliance was rectified in consultation with the EPA, with appropriate long-term corrective management implemented. This non-compliance has not reoccurred, nor is it expected to. Further details of this non-compliance is detailed in the 2017 CAR (Appendix A).

Condition 6 states that a copy of all CEO approved (or varied) Plans and Surveys specified in Condition 5 must be provided to the Department within 20 business days of approval. All but three Plans and Surveys were submitted within the 20 business days. Given Main Roads' compliance history with respect to this matter, the Department issued Main Roads with a warning. All other Plans, Surveys and variances have been, and will continue to be, submitted to the Department within 20 business days of the CEOs approval.

The partial compliance of Condition 5 and Condition 6 in relation to the overall action is considered minor. Lessons learnt for these minor non-compliances have been used to improve the processes during the continued construction of the action.

Overall, no non-compliances were identified which resulted in actual environmental impacts over and above those approved by both the Department and the WA State regulators.

1 INTRODUCTION

This Compliance Assessment Report (CAR) addresses the status and compliance of the Roe Highway Extension with the conditions in Ministerial Statement 1008 (MS 1008). This report has been prepared for the purpose of meeting the requirements of conditions 4–3 and 4–6 of the Statement, which are to submit annual compliance assessment reports to the Chief Executive Officer (CEO) of the Office of the Environmental Protection Authority (OEPA).

This CAR addresses the 12-month reporting period from 2 July 2016 to 1 July 2017.

Main Roads Western Australia is generally compliant with the conditions of MS1008 for the period addressed in the CAR. Two non-compliances were identified in relation to one action within the Construction Environmental Management Plan.

1.1 Project Background

Roe Highway Extension (the Project; Figure 1) was approved under the *Environmental Protection Act 1986* on 2 July 2015 in MS 1008. The Project as proposed involves the construction of approximately 5 km of highway, extending Roe Highway from its current terminus at the Kwinana Freeway in Jandakot to Stock Road in Coolbellup. The proposed extension to Roe Highway is largely located within a primary regional road reserve which adjoins Beeliar Regional Park.

The design and construction of the Project was awarded to the Building Roe 8 Alliance (BR8) formed between Main Roads, CPB Contractors, Georgiou Group, WA Limestone, GHD, AECOM and BG&E. Clearing/site establishment works commenced on 5 December 2016 amid community protest. BR8 has recently changed its name and is now known as the Metropolitan Road Improvement Alliance.

On 12 March 2017, following the WA election, site establishment works were paused, halting any further clearing or other works other than those required to maintain a secured and safe site. On 3 April 2017, the Project was officially suspended. A community led Rehabilitation Working Group was established, which has assumed responsibility for rehabilitating the areas of disturbance to the west of Bibra Drive. The Alliance has undertaken certain tasks to assist the group, including the removal of limestone tracks, asbestos remediation, and planning for the installation of permanent site fencing.

The eastern part of the Project surrounding the Kwinana Freeway and Roe Highway interchange, and continuing towards Bibra Drive, was to provide a new access into the Murdoch Activity Centre. Part of this section of the Project is proposed to proceed in accordance with the conditions in MS 1008.

1.2 Project Approvals

The Project was formally assessed under Part IV of the Environmental Protection Act 1986 (the EP Act) and the EPBC 2009/5031 and approved under MS 1008 on 2 July 2015.

1.3 Proponent Details

The Proponent for the Project is Main Roads Western Australia.

2 CURRENT STATUS

2.1 Works to Date

Site establishment works began on 5 December 2016, which included the commencement of native vegetation clearing on 19th of that same month. As of 19 May 2017, 33.97 ha of native vegetation had been cleared (Figure 1), with the majority of cleared vegetation mulched. A breakdown of the clearing area is shown in the table below. Since May 2017 3-4 small Jarrah trees have been cleared to remove asbestos from the site, no other clearing has occurred.

2.2 Planned Activities

Whilst implementation of the full proposal has ceased the State Government announced on 8 May 2017 that the eastern end of the proposal, known as the Murdoch Drive Connection (MDC) would be implemented immediately with construction to commence by mid-2017.

Construction and operation of the MDC Access will be fully contained in the section of the proposal project development envelope (PDE).

The objective of the MDC is to provide access to the Murdoch Activity Centre and Fiona Stanley Hospital from the south and the east to ensure the full potential of MAC can be realised. Access to Fiona Stanley Hospital and the MAC from Kwinana Freeway Northbound is currently limited to South Street (via Murdoch Drive).

2.3 Site Remediation Activities to the west of Bibra Drive

Main Roads is currently undertaking a number of activities and working with the community and stakeholder representatives to assist with the rehabilitation of the Roe 8 Site west of Bibra Drive. Main Roads will hand over this area as soon as practicable to allow the commencement of the rehabilitation by these community and stakeholder groups The cleared section of the PDE to the west of Bibra Drive in North Lake and Coolbellup is to be rehabilitated as a part of a community led program. Main Roads are currently in the process of remediating this area to ensure a safe and secure site is handed over to the community.

Following a consultation process between Main Roads, community and stakeholders relevant to the Roe 8 Rehabilitation works, a scope of works has been defined to remediate the area for the community led rehabilitation from Bibra Drive to Stock Road. This includes:

- Design and construction of fencing
- Removal of mulch piles
- Asbestos removal
- General civil works to assist with rehabilitation works
- Weed control








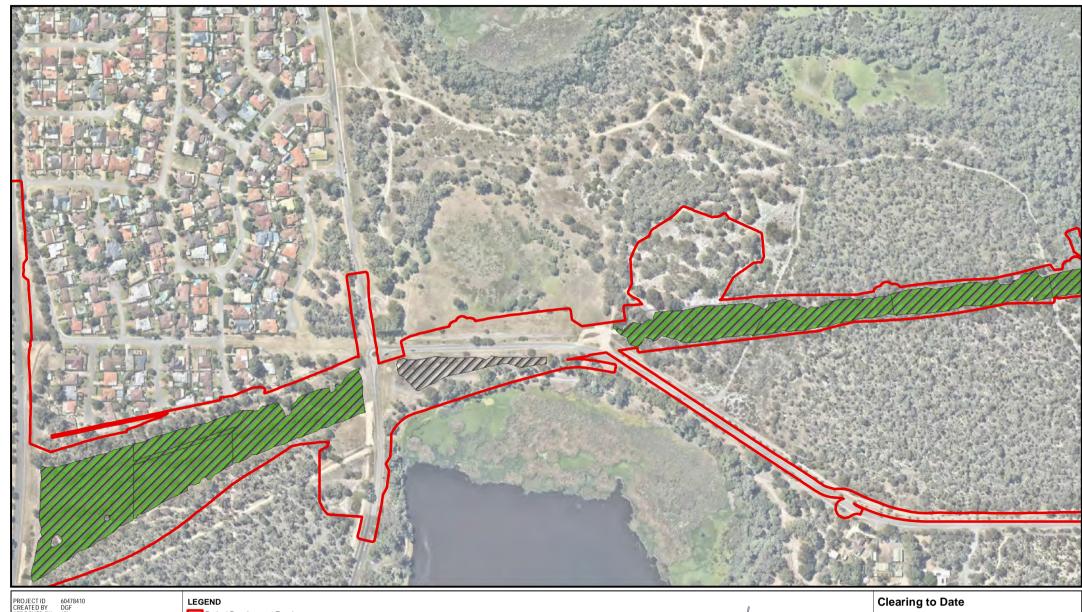
Cleared Native Vegetation within Clearing Area














3 AUDIT PLAN

3.1 Purpose and scope

3.1.1 Purpose

This document is the second Compliance Assessment Report (CAR) addressing the Project.

The CAR has been prepared to address conditions 4-3 and 4-6 of MS 1008 which state:

4-3 After receiving notice in writing from the CEO that the Compliance Assessment Plan satisfies the requirements of condition 4-2 the proponent shall assess compliance

with conditions in accordance with the Compliance Assessment Plan required by condition 4-1.

4-6 The proponent shall submit to the CEO the first Compliance Assessment Report fifteen (15) months from the date of issue of this statement addressing the twelve (12) month period from the date of issue of this statement and then annually from the date of submission of the first Compliance Assessment Report.

The Compliance Assessment Report shall:

- 1. be endorsed by the proponent's Chief Executive Officer or a person delegated to sign on the Chief Executive Officer's behalf;
- 2. include a statement as to whether the proponent has complied with the conditions;
- 3. identify all potential non-compliances and describe corrective and preventative actions taken:
- 4. be made publicly available in accordance with the approved Compliance Assessment Plan; and
- 5. indicate any proposed changes to the Compliance Assessment Plan required by condition 4-1.

Condition 4-1 of MS 1008 referred to above states:

The proponent shall prepare, submit and maintain a Compliance Assessment Plan to the CEO at least six (6) months prior to the first Compliance Assessment Report required by condition 4-6, or prior to implementation, whichever is sooner.

Condition 4-2 of MS 1008 referred to above states:

- 4-2 The Compliance Assessment Plan shall indicate:
- 1. the frequency of compliance reporting;
- 2. the approach and timing of compliance assessments;
- 3. the retention of compliance assessments;
- 4. the method of reporting of potential non-compliances and corrective actions taken;
- 5. the table of contents of Compliance Assessment Reports; and
- 6. public availability of Compliance Assessment Reports.

A Compliance Assessment Plan (CAP) was prepared to address condition 4-1 of MS 1008 (Strategen 2015). The CAP was approved by the CEO of the OEPA on 19 October 2015.

Condition 4-2 of MS 1008 describes what must be contained in the CAP, with point (5) of condition 4-2 requiring that the CAP shall indicate the table of contents of compliance assessment reports. The approved CAP (Strategen 2015) provides this detail, replicated as Table 1 below, with an additional column indicating the corresponding section of this CAR. This CAR has been developed to align with the structure indicated in the CAP, which was guided by Post Assessment Guideline No. 3 Preparing a Compliance Assessment Report (OEPA 2012a).

3.1.2 **Scope**

This CAR has been prepared to assess whether the proponent has been, is being, has not or is not (Section 3.1.2), complying with 12 conditions including Schedule 1 of MS 1008 over the reporting period.

An assessment of compliance with the conditions of MS 1008 is provided in Section 4 and Appendix 2. Further detail with respect to compliance with Schedule 1 of MS 1008 is provided in Appendix 3. Audit table relating to any non-conformances of conditions for the management plans required under MS 1008 are including within Appendix 4.

3.2 Audit Period

This CAR addresses the twelve-month reporting period from 2 July 2016 to 1 July 2017.

3.3 Audit Criteria

Audit criteria were based on the conditions of approval of MS 1008. An audit table has been prepared in accordance with the approved CAP (Appendix 2). The audit table contains each condition separated into audit elements for auditing purposes (i.e. the audit criteria), and includes the following headings:

- Audit code: Ministerial Statement reference number
- Subject: the environmental theme/issue
- Requirement: what the proponent must do
- How: the manner in which the requirements of an audit element should be achieved
- Evidence: information or data collected to verify compliance, i.e. report/letter/site inspection requirements
- Phase: project phase applicable to audit element
- Timeframe: specific timing for achieving the requirements of an audit element
- Status: notes about the fulfilment of compliance using compliance status terms
- Further information: additional comments to support compliance findings, where required

3.4 Methodology

The audit was a mixture of reviewing records from both the MRIA office, and obtaining Main Roads advice on the status and supporting documentary evidence to verify compliance with applicable conditions.

This compliance audit was undertaken by the Metropolitan Road Improvement Alliance on behalf of Main Roads.

3.5 Terminology

The 'Status' field of the audit table (refer to Appendix 2 and Appendix 3) describes the implementation of the action and compliance with the condition, procedure or commitment. Although the CEO of the OEPA makes the final determination of compliance, it is necessary to update this field each reporting period, as the project progresses. The OEPA (2012a, 2012b, 2012c and 2012d) has prepared updated guidance related to the preparation of compliance audits, including generic expressions that are used to identify the status of each item (refer to Table 1 of Appendix 1).

4 AUDIT RESULTS

4.1 Compliance with conditions

This assessment of compliance for this auditing period found that Main Roads is generally compliant with all conditions of MS 1008 in the audit period.

Two non-compliances were identified during the audit period in relation to the MS 1008 condition 7-10:

The proponent shall implement the approved revisions of the Construction Environmental Management Plan required by conditions 7-8 and 7-9.

The following action within this plan was not followed initially:

Ensure stockpiles have appropriate signage, including source location and whether it is from a high-risk area.

Upon investigation, this was found to be a misinterpretation of the definition of 'stockpiles' by Main Roads (Main Roads is responsible for the implementation of the proposal and are therefore responsible for our contractors actions), which was of the view that the mulch heaps did not become stockpiles until they were moved to a storage location. Once this error was identified, signage was installed on all mulch heaps. This was recorded as two non-compliances as it was noted twice during two separate consecutive OEPA audits. Communication with the OEPA confirms this non-compliance is now resolved See Appendix 6. Further details on this non-compliance are detailed in Appendix 4.

A Statement of Compliance has also been included at Appendix 1.

Compliance with the conditions of MS 1008 for the Project has been assessed and reported using the Audit Table provided in Appendix 2.

4.2 Proposed Changes to Compliance Assessment Plan

This CAR has been prepared consistent with the approval CAP (Strategen 2015), no changes are proposed at this stage.

IMPLEMENTATION AUDIT OF STATEMENT 1008 - NON-COMPLIANCE **IDENTIFIED**

The Office of the Environmental Protection Authority (OEPA) has been monitoring Main Roads Western Australia's (MRWA) implementation of the Roe Highway Extension Proposal to ensure compliance with the implementation conditions of Ministerial Statement 1008 (MS 1008). An independent environmental auditor has been retained to assist the OEPA in this matter.

The Implementation Audit Report dated 5 April 2017 (enclosed) details the outcome of the compliance monitoring undertaken for the period commencing 11 February 2017 and concluding on 10 March 2017.

The audit found that MRWA has displayed a high level of commitment and performance in implementing the Proposal in accordance with the MS 1008 conditions and its approved environmental management plans.

I note however that the audit identified non-compliance with one of the management actions identified in its Construction Environmental Management Plan (CEMP) dated November 2016 which was not fully implemented. Specifically, during clearing, MRWA did not erect signs at mulch stockpiles indicating the weed and dieback status of the mulch and source location of the mulch; see tables 3 and 9 of the CEMP. This management action is aimed at preventing the spread of weeds, diseases and pathogens to areas currently free from weeds, disease and pathogens. This issue was also identified in the previous implementation audit dated 20 March 2017.

I note your correspondence of 31 March 2017 confirms that appropriate signage has since been erected at all mulch stockpiles in accordance with the management action required by the CEMP. I now consider that the non-compliance has been addressed and that this matter has now been resolved.

Please find attached a Notice detailing the non-compliance identified by the Implementation Audit dated 5 April 2017 noting that the issue has been resolved and no further action is required.

Roe Highway Extension, Kwinana Freeway to Stock Road, WA (EPBC 2009/5031)

I write in relation to the project for the construction of highway or freeway standard road from the current terminus of Roe Highway at the Kwinana Freeway in Jandakot, to Stock Road in Coolbellup in Western Australia. The project was approved as a controlled action under the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act) on 21 October 2015.

The Department of Environment and Energy (the Department) records show that on 16 November 2016 you provided to the Department, as required under Condition 6 of the approval, three plans and one survey document approved by the Chief Executive Officer (CEO) of the Office of Environment Protection Authority (OPEA). Of those documents provided, three were dated outside the maximum business 20 days following CEO approval.

The pertinent documents are listed below:

- Drainage Management and Monitoring Plan approved on 14 September 2016
- Baseline Flora and Vegetation Condition Survey approved on 6 October 2016
- Flora and Vegetation Monitoring and Management Plan approved on 6 October 2016

Under Condition 6, the approval holder must provide a copy of all CEO approved (or varied) Plans or Surveys specified in Condition 5 to the Department within 20 business days of the Plan or Survey having been approved (or varied) by the CEO.

Section 142 of the EPBC Act requires a proponent to comply with conditions attached to an approval, with penalties for contravening conditions of approval up to \$1,800,000. As an alternative to prosecution, the Department may choose to pursue a range of administrative measures; such as Infringement Notices of up to \$10,800 for each contravention, formal cautions, and directed audits.

I am satisfied that, based on available information, there has been a breach of condition 6 of the approval which has resulted in a contravention of Section 142 of the EPBC Act.

I take into account the compliance history of Main Roads Western Australia with respect to this matter. I have also considered the public interest in this matter as well as the options

Main Roads Western Australia (Main Roads) is preparing to commence the proposed action "Roe Highway Extension, Kwinana Freeway to Stock Road WA" (EPBC 2009/5031). It is expected that the action will commence in December 2016.

Condition 7 of EPBC 2009/5031 relates to the offsetting of residual impacts through providing funds to the Department of Parks and Wildlife (DPAW) for the acquisition of a suitable offset property. Main Roads is required to provide written evidence that the funds have been provided to DPAW prior to the commencement of the action. The written evidence is to include a description and map defining the location and boundaries of the offset property and be accompanied with the offset attributes and a shapefile.

The "offset property" consists of two distinct parcels of land – the "Lake Clifton offset site" and the "Nirimba offset site":

Lake Clifton offset site:

- Lot 1000 Preston Beach Road, Preston Beach
- Part Lot 2657 Old Coast Road, Lake Clifton
- Part Lot 3045 Old Coast Road, Lake Clifton

Nirimba offset site:

Lot 295 Carrabungup Road, Nirimba

Main Roads has provided funding to DPAW for the acquisition of the properties listed above. Please note that the acquisition of the Nirimba offset site included the purchase of Lots 1262 & 842 in addition to Lot 295. The acquisition of the Lake Clifton offset site also included the purchase of Lots 2240 and 2275. Evidence of funding is provided in Attachment 1 "Funding to DPAW".

A description and map of the "offset property", as required by condition 7, is provided within Attachment 2 *Roe Highway Extension Land Acquisition Management Plan*.

The offset attributes and a shapefile are provided within the enclosed CD.

Main Roads considers that this letter and its enclosures satisfy the written evidence required for condition 7 of EPBC 2009/5031.



Condition 8 of EPBC 2009/5031 requires Main Roads to provide written evidence that the offset property has been transferred to the State of Western Australia for the purpose of addition to the conservation estate within 12 months of the commencement of the action. 
