

How you can work with the Transport and Major Infrastructure Portfolio

In accordance with the WA Procurement Rules, early tender advice and tenders over \$250,000 are advertised on Tenders WA (www.tenders.wa.gov.au) and open for public tender. Businesses are encouraged to register on Tenders WA to set up notifications of potential tenders, download tender documents and upload offers.

Contract award details for contracts above \$50,000 are also published on Tenders WA. You are encouraged to view both tenders advertised, and contracts awarded, if you are interested in subcontracting or supply opportunities.

Department of Treasury and Finance Common Use Arrangements (CUA) are another source of supply. Information relating to CUA's can be found on the Department of Treasury and Finance website <https://www.wa.gov.au/government/cuas>

Various forms of contracts are used across the Transport and Major Infrastructure Portfolio agencies (Department of Transport and Major Infrastructure, Main Roads, Public Transport Authority and Office of Major Infrastructure Delivery) to procure works, goods and services.

Some work contracts require companies to be prequalified under the National Prequalification System and have appropriate management and reporting systems in place. To become prequalified for the construction of roadworks and/or bridgeworks, an application form must be completed and submitted.
