#### 1 INTRODUCTION

#### 1.1 Description of Activities

Main Roads Western Australia (Main Roads) constructed the Gateway Perth Airport and Freight Access project (the Gateway project; the Project), which consisted of a series of upgrades and new construction on Tonkin Highway between Great Eastern Highway and Roe Highway, as well as part of Leach Highway from Orrong Road to Perth Airport.


The Gateway project area occurs approximately 8 km east of the Perth central business district in the eastern Perth metropolitan suburbs of Redcliffe, Belmont, Cloverdale, Kewdale, Welshpool and Forrestfield. The construction of the Gateway project was initially completed for Areas 1, 2 and 4 in September 2015 and Areas 3 and 6 in March 2016 (Figure 1). Main Roads commenced work on the proposal in July 2013.

Some minor additional works were undertaken along Roe Highway in Areas 6 in 2017 and other upgrade works were undertaken within the northern Area 1 between 2020 and the first half of 2024.

No construction or clearing activities were undertaken during the reporting period (July 2024 to July 2025).

#### 1.2 Location of the Approved Action

The location of the approved action is shown in Figure 1.

#### 1.3 EPBC 2010/5384 Approval Background

The Project was referred to the Commonwealth Department of the Environment, Water, Heritage and the Arts (DEWHA; now the Department of Climate Change Energy, the Environment and Water (DCCEEW)) in March 2010 for assessment under the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act). The Project was determined to be a Controlled Action on 31 March 2010 due to its potential impacts on listed threatened species and communities and Commonwealth Land. The then Department of Environment (now DCCEEW) granted conditional approval for the Project on 21 February 2013 (EPBC 2010/5384).

Since initial approval, the following correction notices and variation approvals have been issued:

- Corrective Notice 20/03/2013
- Variation Approval 02/06/2013
- Correction Notice 18/06/2013
- Variation Approval 07/10/2013
- Consolidated Approval conditions 07/10/2013.

#### 1.4 Purpose of this Report

This Annual Compliance Report (ACR) has been produced to satisfy Condition 14 of approval EPBC 2010/5384 and covers the period from July 2024 to July 2025.

This report assesses compliance with all conditions of the approval and will be published on Main Roads website.

#### 2 SUMMARY OF COMPLIANCE

Compliance with the conditions of approval will be assessed as one of the following:

- Compliant the condition has been complied with during the reporting period
- Non-Compliant the condition has not been complied with during the reporting period
- Not Applicable the condition falls outside of the scope of the current reporting period and is not relevant.

Conditions deemed completed are shaded grey.

Table 1 in Appendix A of this report details the Project's compliance with regard to each approval condition over the 12 month reporting period: 31 July 2024 to 30 July 2025.

As reported in the 2024 ACR, the Project was found to be non-compliant with Condition 20 of EPBC Approval 2010/5384, which relates to the monitoring and maintenance requirements within the approved Keighery's Macarthuria Offset and Management Plan. Main Roads has been working with the Department to develop an approach to meet the objectives of Condition 20.

The specific underlying causes of failure to establish *Macarthuria keigheryi* in the offset site have not been determined. While it is likely that the reasons for the poor establishment are multi-faceted, the biology of *M. keigheryi* is considered a potentially significant limiting factor given it is a disturbance specialist, fire ephemeral species, that spends much of its lifecycle present as seed or below ground, waiting for stimulus to emerge, making it difficult to determine whether the translocation has been successful.

#### 2.1 Corrective Measures

Given the lack of success in achieving the requirements of Condition 20, on 23 July 2025, DCCEEW advised Main Roads that it intended to create a Directed Variation to replace Condition 20 and revise the *Keighery's Macarthuria* Offset Management plan. The intent of the revised Offset Management Plan and Conditions of Approval will be to appropriately account for and mitigate the impact on the species going forward.

Main Roads is liaising with the State Department of Biodiversity, Conservation and Attractions (DBCA) (and other relevant stakeholders as required) to agree on an alternative offset strategy and to revise the Keighery's Macarthuria Offset Management plan, for submission to the Department.

#### 2.2 New Environmental Risks

No new environmental risks for the project have been identified during the reporting period.
