1. Introduction

The Mitchell Freeway provides the primary road access route from the Perth north-west corridor towards the City of Perth. The freeway previously terminated at Burns Beach Road and was constructed in several stages since the 1960's, with further extensions and widening works planned for the near future.

The Mitchell Freeway Extension (the 'Project') to which this compliance report relates, is located within the City of Wanneroo and the City of Joondalup and consists of the extension of the freeway from Burns Beach Road to Hester Avenue. The Project included the following works:

- Associated interchanges at Burns Beach Road, Neerabup Road and Hester Avenue;
- The duplication of Hester Avenue from Hidden Valley Retreat to Wanneroo Road;
- The duplication of Wanneroo Road from Flynn Drive to Hall Road;
- Upgrade of Neerabup Road from Connolly Drive to Wanneroo Road; and
- Associated underpasses and pathways.

1.1 Approval under the Environment Protection and Biodiversity Conservation Act 1999

The Project was referred to the then Department of the Environment and Energy (now Department of Agriculture, Water and Environment; DAWE) for assessment under the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act) as the Project was deemed to potentially impact significantly on the listed threatened species, Carnaby's Black Cockatoo (*Calyptorhynchus latirostris*). The Project was determined by DAWE to be a 'Controlled Action' and was assessed through Preliminary Documentation. The DAWE issued approval of the Project on 2 September 2014 (EPBC 2013/7091) and included a number of conditions that Main Roads Western Australia (Main Roads) is required to fulfil.

1.2 Purpose of this Report

Construction of the Project commenced on 27 May 2015. This compliance report has been produced as required by Condition 7 of EPBC approval 2013/7091. Main Roads did not submit the 2019 Annual Compliance Report for approval 2013/7091 (refer to non-compliance at Item 7 in Table 1) and as such, Table 1 of this report outlines the compliance with each approval condition over the past 24 month period, 27 May 2018 to 27 May 2020.

The Project reached practical completion and subsequently opened to the public in August 2017.

2. Compliance

Approval of Black Cockatoo Avoidance and Mitigation Plan Mitchell Freeway Extension between Burns Beach Rd and Hester Av, Neerabup, WA (EPBC 2013/7091)

I refer to your letter dated 14 October 2014 from you, to Nikki Ward of this department, which enclosed a copy of the Black Cockatoo and Avoidance Mitigation Plan – Mitchell Freeway Extension, as required under condition 2 of the approval decision dated 2 September 2014.

The Black Cockatoo and Avoidance Mitigation Plan – Mitchell Freeway Extension has been reviewed by officers of the department and has been found to meet the requirements of the condition. On this basis, and as delegate of the Minister for the Environment, I have decided to approve the Plan.

In accordance with condition 2 of EPBC 2013/7091 each approved plan must be implemented. In 2013 the Project was referred to the Department of Environment and Energy (DoEE) for assessment under the *Environmental Protection and Biodiversity Conservation Act, 1999* (EPBC Act) due to a potentially significant impact on Carnaby's Black Cockatoo (*Calyptorhynchus latirostris*), a listed threatened species. DoEE determined the Project to be a 'controlled action' and was assessed through Preliminary Documentation. Approval of the Project was issued by DoEE on 2 September 2014 (EPBC 2013/7091) and includes a number of conditions that Main Roads is required to achieve.

The purpose of the opening meeting was to discuss the scope of the audit and the audit process. The methods to be used by the auditor to conduct the audit were explained. It was stated that the auditor would be interviewing personnel, reviewing site management plans, examining records and conducting a site inspection in order to address specific compliance requirements.

3.3.2 AUDIT INTERVIEWS

Audit interviews were conducted by the auditor on 4 May 2017 with David McLean of CPB Contractors. The interview with Marni Baetge, the Main Roads representative occurred by phone on 26 April 2017 with subsequent information provided by email.
