# 1 INTRODUCTION




Figure 1: Perth Darwin National Highway - EPBC 2013/7042 approval area

Main Roads Western Australia (Main Roads WA) is currently constructing a new alignment for the Perth-Darwin National Highway (PDNH) between the Tonkin Highway and Reid Highway junction in the south and the Brand Highway and Great Northern Highway at Muchea in the north, north-east of Perth (the Project). The Project includes construction of a dual carriageway highway and includes grade separated interchanges at connecting roads and the reservation for a potential future rail (Figure 1).

The objectives of the Project are to:

- Improve freight capacity, efficiency and productivity;
- Reduce urban congestion now and into the future;
- Reduce pressure on the Great Northern Highway through the Swan Valley (existing major northern route) by shifting majority of heavy vehicles to the PDNH;
- Improve road safety in line with the State's 'Towards Zero' policy; and
- Improve amenity in the Swan Valley for residents and tourists.

Key construction works of the Project include:

- Major interchanges at Reid Highway and Tonkin Highway intersection;
- Other interchanges at Stock Road, Neaves Road, Brand Highway, Hepburn avenue and Gnangara Road;
- Flyovers at Marshall Road, Muchea South Road, railways and Ellen Brook;
- A deviation at Brand Highway; and
- New cycling and pedestrian facilities including a four metre wide shared path to Ellenbrook.

As at 31 March 2019, construction works from Reid Highway to the Gnangara Road intersection are complete and is now open to the public. It is anticipated that the entire Project to Muchea Road, will be completed and open to the public by the end of 2019.

## 1.1 Approval under the *Environment Protection and Biodiversity Conservation Act 1999*

The Project was referred to the Department of the Environment and Energy (DotEE; the 'Department') for assessment under the *Environmental Protection and Biodiversity Conservation Act 1999* (EPBC Act) as the Project was deemed likely to have a significant impact on a number of Matters of National Environmental Significance including threatened flora and fauna species, ecological communities and migratory species.

The Department issued approval of the Project on 2 December 2016 (EPBC 2013/7042) and included a number of conditions that Main Roads WA is required to fulfil.

## 1.2 Purpose of this Report

Construction of the Project commenced 31 March 2017. This compliance report has been produced as required by Condition 7 of approval EPBC 2013/7042. Table 1 of this report outlines compliance with each approval condition over the 12 month period 31 March 2018 to 31 March 2019.

**PERTH-DARWIN NATIONAL HIGHWAY (SWAN VALLEY SECTION) –  
MINISTERIAL STATEMENT 1036 – LAND ACQUISITION AND REHABILITATION  
OFFSETS STRATEGY – APPROVED**

Thank you for your letter of 11 December 2018 submitting the Land Acquisition and Rehabilitation Offsets Strategy Perth-Darwin National Highway (Swan Valley section) Rev 3a, December 2018 to the Department of Water and Environmental Regulation (DWER) for review.

I note the document has been prepared to satisfy conditions 16-8 and 16-9 of Ministerial Statement 1036 which state:

16-8 Within twelve months of the publication of this Statement, the proponent shall prepare and submit a Land Acquisition and Rehabilitation Offsets Strategy to the CEO, with the objective of counterbalancing the significant residual impact to:

- (1) 5.5 ha of Yanga Vegetation Complex;
- (2) 129.9 ha of Bush Forever sites;
- (3) 5.2 ha of *Calyptorhynchus latirostris* (Carnaby's black cockatoo) foraging habitat;
- (4) 21.4 ha of *Calyptorhynchus banksii naso* (forest red-tailed black cockatoo) foraging habitat; and
- (5) 16 ha of Conservation Category Wetlands.

16-9 The Land Acquisition and Rehabilitation Offsets Strategy required by condition 16-8 shall:

- (1) identify an area or areas to be protected, managed and/or restored for conservation or enhancement of the values identified in condition 16-8;
- (2) identify the area(s) of land to be protected, managed and/or restored which must contain:
  - (a) no less than 48 ha of wetlands which are of the same quality as Conservation Category Wetlands at the time of acquisition or after rehabilitation;
  - (b) 181 ha with vegetation communities and/or complexes and conditions commensurate with the Bush Forever sites being impacted; and
  - (c) no less than 5.5 ha of Yanga Complex;
- (3) include a completed WA Offsets Template, as described in the WA Environmental Offsets Guidelines 2014, as well as the Commonwealth's Offset Assessment Guide, to demonstrate how the proposed offset counterbalances the significant residual impact to:
  - (a) 5.2 ha of *Calyptorhynchus latirostris* (Carnaby's black cockatoo) potential foraging habitat; and
  - (b) 21.4 ha of *Calyptorhynchus banksii naso* (forest red-tailed black cockatoo) potential foraging habitat;
- (4) identify the environmental attributes of the offset area(s);
- (5) commit to a protection mechanism for any areas of land acquisition, being either the area is ceded to the Crown for the purpose of conservation, or the area is managed under a Conservation Covenant in perpetuity;
- (6) if any land is ceded to the Crown for the purpose of conservation, the proponent will determine:
  - (a) the quantum of, and provide funds for, the upfront works associated with establishing the conservation area;
  - (b) the quantum of, and provide a contribution of funds for, the management of this area for no less than seven years;
  - (c) the quantum identified in conditions 16-9(6)(a) and 16-9(6)(b) shall provide for the requirements defined in condition 16-9(7)(a) to be met; and
  - (d) an appropriate management body for the ceded land;
- (7) state the management and/or rehabilitation actions to be undertaken including:
  - (a) the objectives and targets to be achieved, including completion criteria;
  - (b) the consistency of the objectives and targets identified in condition 16-9(7)(a) with the management objectives of the relevant Recovery Plans;
  - (c) management and/or rehabilitation actions and a timeframe for the actions to be undertaken;
  - (d) risk management;
  - (e) funding arrangements and timing of funding for conservation activities; and
  - (f) monitoring, reporting and evaluation mechanisms for management and/or rehabilitation actions;

(8) define the role of the proponent and/or third parties.

I also note that condition 16-10 requires that after receiving notice that the Land Acquisition and Rehabilitation Offsets Strategy satisfies the requirements of condition 16-9, the proponent shall:

- implement the actions in accordance with the requirements of the approved Strategy
- continue to implement the approved Strategy until it is demonstrated that the completion criteria have been met and the implementation actions are no longer required.

I am satisfied with the preparation of the Land Acquisition and Rehabilitation Offsets Strategy Perth-Darwin National Highway (Swan Valley section) Rev 3a, December 2018, and consider the requirements of conditions 16-8 and 16-9 of Ministerial Statement 1036 have been met.

Please note any changes to the management actions or targets of the Land Acquisition and Rehabilitation Offsets Strategy Perth-Darwin National Highway (Swan Valley section) Rev 3a, December 2018 would require the approval of the DWER.

Main Roads Western Australia (Main Roads) is currently implementing the action approved under EPBC 2013/7042 Perth-Darwin National Highway (Swan Valley Bypass). The project (also known as Northlink) is due to be completed later this year.

Condition 3 of EPBC 2013/7042 requires Main Roads to provide the Department of Environment and Energy with state approved "Land Acquisition and Rehabilitation Offsets Strategy" (LAROS) as required under condition 16-8 of the WA approval within one month of the approval of the LAROS by the WA government. The WA Department of Water and Environmental Regulation, EPA Services, approved the LAROS on 7 January 2019.
