#### CONSERVATION AND LAND MANAGEMENT ACT 1984

##### DRAFT FOREST MANAGEMENT PLAN 2024-2033

1. Notice is hereby given that the *Draft Forest Management Plan 2024-2033* (the draft plan) is available for public comment.
2. The draft plan has been prepared in accordance with Part V of the *Conservation and Land Management Act 1984* (CALM Act).
3. The draft plan applies within the geographic area of the department's Swan, South West and Warren regions (other than marine waters), and the lands collectively referred to as 'Redmond' forest block within the South Coast region. The planning area covers the management of approximately 2.5 million hectares of the following lands vested in the Conservation and Parks Commission—
  - Nature reserves, national parks, conservation parks and other land referred to in section 5(1)(g) and (h) of the CALM Act that has a conservation purpose.
  - Indigenous State forest and timber reserves, including State forest classified as a forest conservation area through section 62(1) of the CALM Act.
  - State forest and timber reserves planted with exotic species. The application of the plan to these areas is limited to specific proposed management activities labelled for plantations in section 5.6.3.

#### PLUMBERS LICENSING AND PLUMBING STANDARDS REGULATIONS 2000

##### DRAINAGE PLUMBING WORK INSPECTION NOTIFICATION REQUIREMENTS NOTICE 2022

This notice is given by the Plumbers Licensing Board in accordance with regulation 70(1) of the *Plumbers Licensing and Plumbing Standards Regulations 2000*.

#### 1. Citation

This notice is the *Drainage Plumbing Work Inspection Notification Requirements Notice 2022*.

#### 2. Commencement

This notice comes into operation as follows—

- (a) clauses 1 and 2—on the day on which this notice is published in the *Government Gazette*; and
- (b) the rest of the notice—on the day after that day.

#### 3. Terms used

In this notice—

**Board** means Plumbers Licensing Board.

**business day** means a day other than a Saturday, a Sunday, a public holiday or a day falling between 25 December in any year and 1 January in the following year.

**contractor** means a person licensed as a plumbing contractor under the *Plumbers Licensing Act 1995*.

**eNotice** means the internet-based, electronic platform operated by the Department of Mines, Industry Regulation and Safety for generating and giving notices required under the *Plumbers Licensing Act 1995* and various other acts.

**r.70 notice** means a notice given by a contractor to the Board, in accordance with this notice, to inform the Board that major plumbing work which is drainage plumbing work, for which the contractor is responsible, is ready for inspection.

#### 4. Means of giving r.70 notice

In cases where the corresponding notice of intention has been given by the contractor to the Board via eNotice, an r.70 notice is to be given on eNotice.

##### (b) other means

Subject to clause 4(c) of this notice, in cases where the corresponding notice of intention has been given by the contractor to the Board other than via eNotice, an r.70 notice is to be given—

- (i) verbally by telephoning 08 6251 1377 between 8:30am and 4:30pm on a business day;
- (ii) in writing by SMS to 0417 209 818; or
- (iii) in writing by email to [plumbinginspections@dmirs.wa.gov.au](mailto:plumbinginspections@dmirs.wa.gov.au).

##### (c) other means (transitional)

For a period of 90 days after the date on which this notice being published in the *Government Gazette*, in cases where the corresponding notice of intention has been given by the contractor to the Board other than via eNotice, an r.70 notice may be given—

- (i) in writing by email to [plumbingaudits@commerce.wa.gov.au](mailto:plumbingaudits@commerce.wa.gov.au); or
- (ii) in writing by fax to 1300 449 185.

#### 5. Time for giving r.70 notice

### BUSH FIRES ACT 1954

*Shire of Collie*

#### PROHIBITED AND RESTRICTED BURNING

All Areas in the Shire of Collie

Pursuant to section 24G(2) and section 25(1a) of the *Bush Fires Act 1954*, the burning of garden refuse and camp and cooking fires is prohibited in all areas within the Shire of Collie during the **Prohibited Burning Period**. Furthermore, pursuant to section 24G(2) of the Act the burning of **garden refuse** is prohibited within the Shire of Collie during the **Restricted Burning Period**, unless a permit to burn has first been obtained from a Fire Control Officer.

Pursuant to section 25(1a) of the Act the burning of **camping and cooking fires** is allowed in the Shire of Collie during the **Restricted Burning Period**, unless otherwise sign posted or fire danger rating is high or above.

On any day during the restricted burning period where either fire danger rating is **High, Extreme or Catastrophic**, garden refuse, wood or solid fuel barbecues, camp and cooking fires or (pizza ovens without DFES exemption) are NOT permitted to be used under any circumstances. Permits are automatically cancelled on these days.

Due to unseasonable weather conditions Restricted and Prohibited burning dates may be extended or shortened.

Fire Control Officers have the authority under the *Bush Fires Act 1954* to halt any activity or operation that they deem as hazardous or likely to start a fire.

Penalties will be enforced by the Shire of Collie for failing to comply with the annual Firebreak notice.

Please note: All properties are required to be compliant by 1 December 2022 through to 31 May 2023 and firebreaks are required to be a minimum of 3 meters wide with a vertical clearance of 5 meters.

**7. Modification of mass and dimension requirements**

A vehicle must not exceed the modified mass and dimension requirements specified in the *Operating Conditions*.

**8. Road Access**

A vehicle must only travel on a road in accordance with the access requirements specified in the *Operating Conditions*.

**9. Compliance with Operating Conditions**

**TN403****ROAD TRAFFIC (VEHICLES) ACT 2012****2 AXLE FIRE TRUCK ORDER**

I, Peter Woronzow, in my capacity as Commissioner of Main Roads, hereby make an Order in under section 33 of the *Road Traffic (Vehicles) Act 2012* for the modification of mass requirements for certain 2 axle fire trucks, subject to the following conditions.

**1. Revocation of previous notices**

The *2 Axle Fire Truck Order*, issued by the Commissioner of Main Roads under the *Road Traffic (Vehicles) Act 2012* on 19 January 2021, is revoked

**2. Citation**

This is the 2 Axle Fire Truck Order.

**3. Commencement**

This Order takes effect on the day that it is published.

**4. Period for which Order applies**

This Order has effect from the first day of January of each year to the last day of December of each year, until it is revoked.

**5. Interpretation**

In this Order—

**Fire Truck** means a 2 axle special purpose motor vehicle built to carry out firefighting or fire prevention operations or to take part in authorised fire control exercises; and

**Axle Spacing** means the distance from the centre of any single axle to the centre of any other single axle.

**6. Application**

This Order applies to a fire truck that—

- (a) has a single steer axle at the front with single tyres of at least 330 mm in width; and
- (b) has a single drive axle at the rear with—
  - i. dual tyres of at least 279 mm in width; or
  - ii. single tyres of at least 458 mm in width; and
- (c) has an axle spacing between 4.3 metres and 4.5 metres.

**7. Modification of Mass Requirements**

- (1) The steer axle may exceed 6.0 tonnes, provided it does not exceed 7.1 tonnes.
- (2) The drive axle may exceed 9.0 tonnes, provided it does not exceed 10.6 tonnes.

**8. Access Requirements**

(1) A fire truck may be driven on any road within the State of Western Australia, subject to subclause 8(2).

(2) A fire truck must not be driven over a bridge listed in the 2 Axle Fire Truck Restricted Structures, which is available as a document or in the RAV Mapping Tool on the Main Roads website.

**TN404****ROAD TRAFFIC (VEHICLES) ACT 2012****CONTROLLED ACCESS BUS ORDER**

I, Peter Woronzow, in my capacity as Commissioner of Main Roads, hereby make an Order in accordance with Section 40 of the *Road Traffic (Vehicles) Act 2012*, to provide an access approval for Controlled Access Buses, subject to the conditions specified in this order.

**1. Revocation of previous notices**

The *Controlled Access Bus Order 2021*, issued by the Acting Commissioner of Main Roads under the *Road Traffic (Vehicles) Act 2012*, is revoked

**2. Citation**

This is the Controlled Access Bus Order.

**3. Commencement**

This Order takes effect on the day that it is published.

**4. Period for which Order applies**

This Order has effect from the first day of January of each year to the last day of December of each year, until it is revoked.

**5. Interpretation**

In this Order—

**Bus** means a motor vehicle built mainly to carry people that seats more than 9 adults (including the driver).

**Controlled Access Bus** means a bus, except an articulated bus, over 12.5 m long.

**6. Application**

(a) This Order applies to a Controlled Access Bus not exceeding 14.5 metres in length.

(b) This Order applies to a Controlled Access Bus that has been converted into a mobile home.

**7. Road Access**

A Controlled Access Bus may be driven on any road within the state of Western Australia.

**8. Route Survey**

Prior to departure, the operator or driver of a Controlled Access Bus must plan and assess the route of travel to ensure it is suitable for use and any required turning movements at intersections can be negotiated safely without interfering with other traffic or roadside furniture.
