





Causeway Pedestrian and Cyclist Bridges Project – McCallum Park

The Causeway Pedestrian and Cyclist Bridges project will see two iconic cable stayed bridges built, comprising a 6-metre-wide segregated path linking Victoria Park foreshore at McCallum Park with Heirisson Island and Perth's CBD at Point Fraser.

Marine Piling and Out of Hours Works

Construction in the river is about to commence for the Causeway Pedestrian and Cyclist Bridges Project. These works will involve marine piling, which is the process of installing piles into the riverbed to create a solid foundation for the bridges to be built on.

Piling is due to commence in the southern channel (Victoria Park side of Heirisson Island) in late November 2023. Both marine works and landside construction activities will occur between 7am and 7pm Monday to Saturday.

In addition, to facilitate ongoing deliveries of marine equipment, assembly of barge and crane components

and dust management using a water cart at the McCallum Park site, approval has been provided by the Town of Victoria Park for out of hours works on Sundays between 7:30am to 5pm from Sunday 19th November until Sunday 17th December 2023.

Piling of the southern channel (Victoria Park side of Heirisson Island)

- 7am to 7pm, Monday to Saturday from late November to late January 2024
- Marine works and landside construction activities
- Adhere to signage

Associated works at McCallum Park (Out of Hours)

- 7:30am to 5pm, every Sunday from 19th November to 17th December 2023
- Facilitating ongoing deliveries and dust mitigation
- Adhere to signage

For the safety of the public and construction workers, an exclusion boundary is in place across the southern channel for the duration of works. This is not a gazetted navigational channel and only power boats and water sports vessels are usually allowed access. We have been engaging extensively with the Burswood Aquatic Management and the Department of Transport regarding this closure.

Construction is not due to commence in the northern navigational channel (Perth side of Heirisson Island) until early 2024, with work ongoing until Spring 2024. The channel will continue to remain open, with the flow of the river traffic being managed during work activities.

Noise Management

To minimise any potential impacts, a Noise and Vibration Management Plan is in place to regulate and manage vibration and noise generated by construction activities. While we will actively seek to limit our impact, we understand that works may, at times, cause disturbances and we apologise in advance for any inconvenience. This plan has been approved by the Town of Victoria Park.
